- To be considered in the first round of screening, your application must be postmarked or delivered in person **no later than January 6, 2012.** Applications received after the deadline will be considered on a space-available basis. **Out-of-district applicants may be considered on a space-available basis after June 4, 2012.**
- Complete one application for each Magnet program to which you are applying.
- If you are applying for a **Vanguard Magnet program**, you must complete only a Vanguard application. To obtain a copy of the Vanguard application, contact the Vanguard Magnet school you are interested in or download one from www.houstonisd.org/magnet.
- You will be notified by mail of the status of your application on **March 23, 2012.** No status updates can be given before this date.
- For your application to be complete, you must supply copies of the following to each school where you apply:

Kindergarten or first time in HISD

- **Proof of age 5 by 9/1/2012** (copy of birth certificate preferred)
- Pre-K Progress Report (if applicable)

Grades 1–5

- **First grading period of current report card**
- **Previous year's final report card**

- Proof of HISD residency is required for all applicants (apartment rent receipt, utility bill receipt, or statement of residence).
